Meeting dispatchable location requirements and save lives with faster, accurate location data.

Carrier Billing Information Repository (CBIR) is a database that can be queried during a 911 call to deliver a dispatchable location to PSAPs based on the subscriber billing addresses. Dispatchable location is a definitive and deliverable location that PSAPs can use for proper resolution to a request for assistance. It is more effective for saving lives.

In the FCC's Sixth Report and Order, dispatchable location became a requirement. The mandate requires wireless providers, beginning January 6, 2022, to provide dispatchable location with wireless 911 calls when it is technically feasible and cost-effective to do so. Non-nationwide CMRS providers will also be required to provide dispatchable location or z-axis technology throughout their network footprint by April 2026.

How It Works

Carriers will provide to Intrado a wholesale extract of their subscriber billing address database, which can be updated monthly. Intrado loads this information into the secure database, then provides an FQDN and port as well as the appropriate format for sending the data to the PSAP.

When a subscriber makes a 911 call, and a proximity check determines the subscriber is within a predefined range of their billing address, that address will be sent as a dispatchable location. Typically, x/y/z would be delivered to the PSAP. With Carrier Billing Information Repository, Intrado can provide the billing address along with x/y/z, giving PSAPs verifiable data to determine a dispatchable address for first responders – improving location accuracy and response times.

Key Dates

- CMRS providers to provide dispatchable locations information with 911 calls, if technically feasible and cost-effective, by January 6, 2022
- By April 3, 2025, nationwide CMRS providers must provide z-axis location information on a nationwide basis
- Non-nationwide CMRS providers have an additional year – until April 3, 2026, to provide z-axis location information throughout their network area

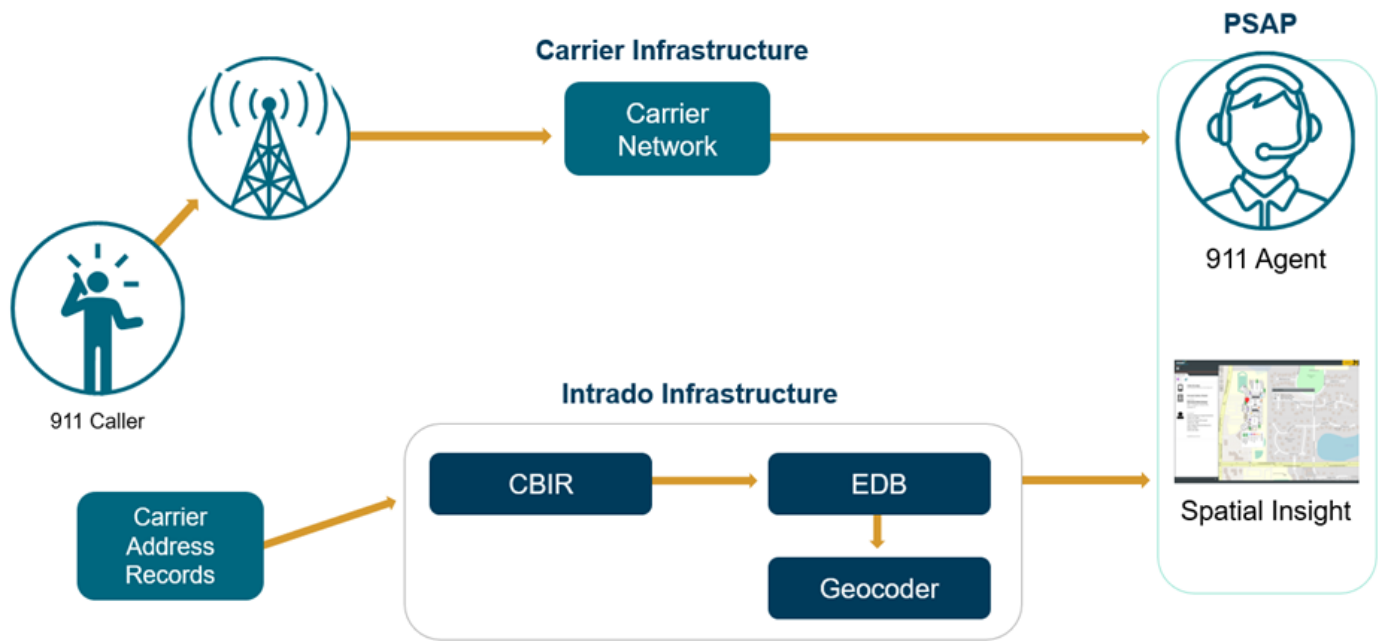
